Note on methods of examination and adaptation for draft contributions

Pursuant to article 10.2 of the rules of procedure, each national delegation can table a draft contribution to COSAC. To increase efficiency of COSAC proceedings, it appears necessary to clarify requirements for tabling and reviewing of possible draft contributions. The purpose is to enable a real work prior to review by COSAC.

- 1) First, possible drafts should be sent to the Presidency before **April 5**, by e-mail when possible (presidence@cosac.org) or by fax. (+ 46 8 786 61 63) All drafts should preferably deal with national parliaments and the EU, or one of the other themes on the agenda of COSAC. To prevent any delay in the circulation of the documents, it is required to send drafts **both in French and in English**. Finally, the draft should not exceed **one page**: experience shows that delegations find too long texts more difficult to review.
- 2) The Presidency will make the draft contributions available on the COSAC web site (www.cosac.org) and send them to delegations by e-mail. At the working group meeting on April 9, draft contributions on the role of national parliaments will be discussed. If time allows, the working group might also take other subjects under consideration.

- 3) The Presidency will send draft COSAC contributions for comments after the working group meeting. The timetable will be decided on at the working group meeting.
- 4) The preparatory meeting of chairmen of delegations, in pursuance of art. 10.4 of the rules of procedure, will take place on Monday May 21 at 5.45 PM, after the first day of debates of COSAC.
